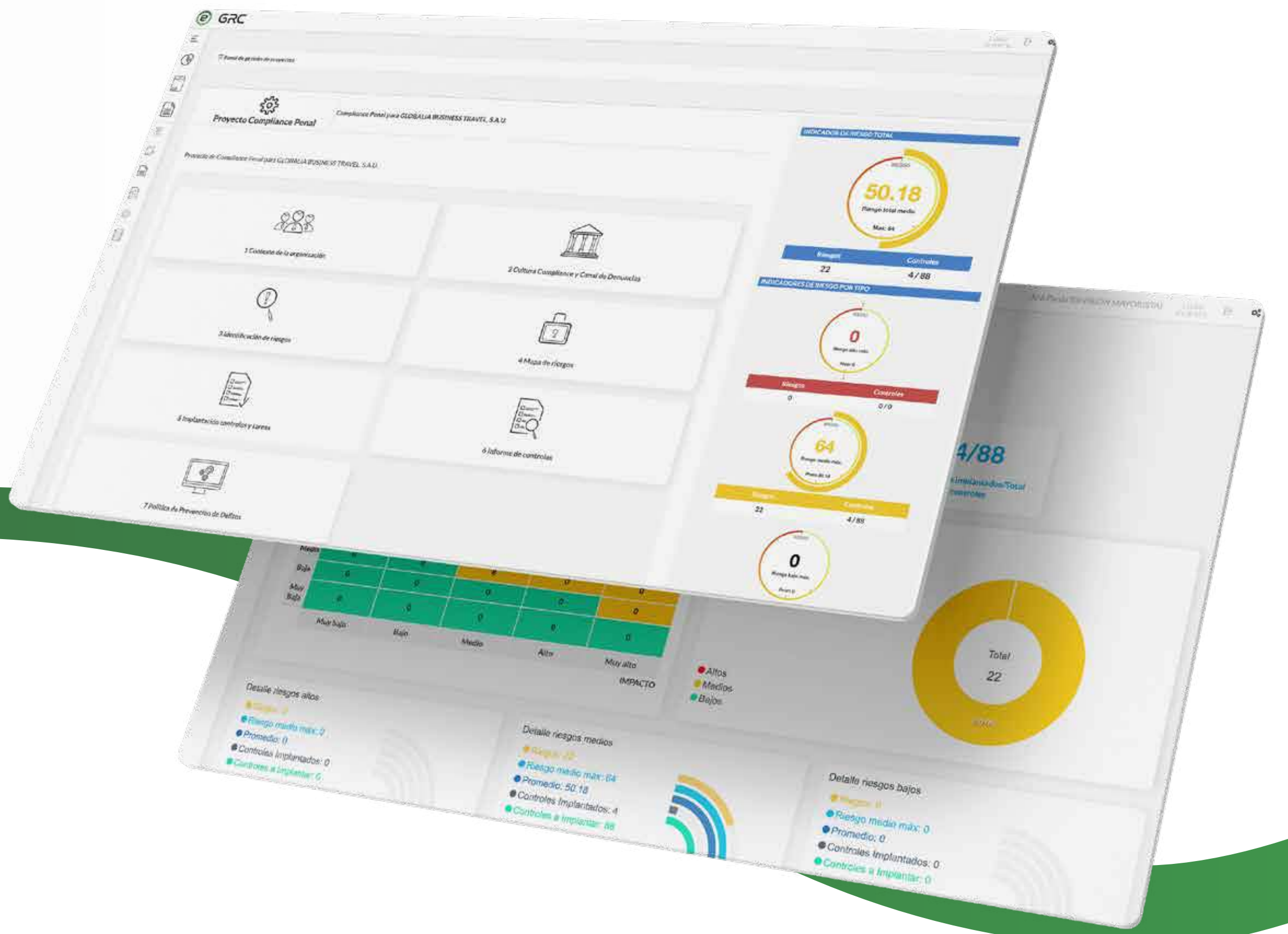

MIA is the first Legal Breach Hunting solution with Artificial Intelligence that analyzes company information to detect legal vulnerabilities that can avoid heavy fines.

It is designed to detect legal breaches in multiple regulatory frameworks. MIA is trained in 27 articles of the GDPR and 57 articles of the Penal Code. In the last 3 years more than 680 penalties worth €595 million have been issued on these articles and its growth rate is 300% per year.
